I acknowledge and agree that travel to and from and within foreign countries does include certain risks, dangers, hazards and potential liabilities including but not limited to personal injury, death, property damage, economic or other loss, expenses, costs, service provider bankruptcy or failure to perform, delays or cancellations of transportation (including flights), hotel rooms or other arrangements, political instability, laws or customs which I may not be aware of or accustomed to, attack by wildlife or others, inferior medical services, insurrection, terrorism, customs or visa difficulties, severe, unusual, extreme or different weather, severe heat, flood, earth quake or other natural calamity, becoming lost or separated from guides or other participants, the negligence of other participants or guides, failure to remain in designated areas, or the Trip's cancellation, delay or curtailment (the "Risks") and I FULLY AND VOLUNTARILY ASSUME THESE RISKS and other associated risks as a condition of my participation in the Trip. I further acknowledge and agree that there may be further risks mentioned in the most current Canadian Department of Foreign Affairs and International Trade Travel Report which I have or will read prior to my

- 3. I HEREBY INDEMNIFY AND SAVE HARMLESS the Society from any and all liability, claim, loss, cost, expense, debt, damages, judgement or declaration related to, arising from or associated with the Risks, or the Trip, or my participation in the Trip.
- 4. This Waiver shall be binding and effective against myself and my heirs, next of kin, executors and representatives.
- 5. I acknowledge and agree that in entering into this Waiver I am not relying on any oral or written representations or statements made by the Society or anyone else other than that which is set out expressly in this written Waiver.
- 6. The laws of Alberta Canada will apply to this Waiver and its interpretation, and the Courts of the Province of Alberta shall have the exclusive jurisdiction to interpret or adjudicate this Waiver.
- 7. I ALSO HEREBY CONSENT to the Society using any photographs or videos taken of me during my participation in the Trip for publication on the Society's website, facebook page or promotional materials.
- 8. I also acknowledge and agree that prior to departure on the Trip I am fully responsible for obtaining any necessary inoculations, and a valid passport and Visa(s), to allow me to enter and travel in India, and that those inoculations, passport and visa(s) will remain valid during the duration of the Trip.
