NOTE: The first appearance of a term in bold in the body of this Policy (or its Appendixes) means that the term is defined in the Definitions part of this Policy.

PURPOSE:

This **Policy** outlines eligibility for membership in the **Society**, as well as the privileges and responsibilities of being a **Society Member**. This Policy supports the implementation of the **Vision**, **Mission**, **Organizational Values**, and **Objects** of the Society.

POLICY STATEMENT:

- The Society follows the **Gaden Tripa Tradition of the Gelugpa Lineage of Tibetan Buddhism** and welcomes any individual who has an interest in connecting with the teachings and philosophies of Tibetan Buddhism. Any individual who has an appreciation for the activities of the Society is welcome to apply to become a Society Member.
- The intention of this Policy is to facilitate a sense of belonging to a welcoming and comfortable place that supports spiritual growth. Through being a Society Member, individuals can develop a relationship with a uniquely qualified Spiritual Master who offers meaningful teachings and practices that benefit personal development. Due to the **Spiritual Director**'s kindness, depth of knowledge, and wisdom, the benefit of the teachings continuously increases as an individual's own understanding grows. As part of a spiritual community, Society Members benefit from being part of a group that is pursuing similar spiritual goals. Their growth is supported by the opportunity to contribute back to the Society for the benefit of others. Becoming a Society Member also creates more opportunities for

timely communication around upcoming events, access to the Dharma library, and several other benefits as outlined below.

• A **Membership Matrix** (see Appendix A to this Policy) has been created to allow perspective members to determine which category of membership is the best fit for them. All new memberships begin at the Lotus category and members are welcome to request a change in membership category after one year. As a Society Member's interest and involvement grows over time, they will see that the Membership Matrix is dynamic and offers increasing privileges and responsibilities that suit their spiritual needs.

APPLICABILITY:

This Policy applies to any individual seeking membership in the Society.

POLICY ELEMENTS:

1. Non-discrimination

All individuals age 12 or older are welcome to apply for membership. Our Sanga works toward creating a culture free from bullying, abuse, harassment and discrimination based on race, national or ethnic origin, gender identity or expression, sexual orientation, cultural background, or disability. We are committed to fostering a membership that welcomes, respects and values the diversity of individuals and supports them to actively engage in our community.

2. Upholding the Lineage

The Gaden Tripa Tradition of the Gelugpa Lineage of Tibetan Buddhism is the foundation of the Society. Upholding this spiritual lineage is of vital importance, not only to the Society but also to Society Members' attainment of the fruits of their study and practice.

3. Voting Rights

Recognizing that voting rights have the potential to influence the future direction of the Society, these rights are reserved for **Jewel Members** and **Vajra Members** (who are **Voting Members**) as they have made a personal choice to become more involved and invested in the affairs of the Society.

4. Membership Categories

4.1 Categories were developed to support Society Members in becoming conscientious of several key points when choosing a membership category. More specifically, membership decisions can now explicitly reflect the individual's interest in the Society's Vision, Mission, Organizational Values, and Objects. There are 4 categories of membership in the Society. The Honorary Life Member category is reserved for the Spiritual Director(s). The 3 remaining membership classes are: 1) Lotus Member, 2) Jewel Member, and 3) Vajra Member.

- 4.2 All new members are invited to begin within the Lotus category for at least one year. After that time period, continuing members are able to apply for Jewel membership level upon approval of our spiritual director. The Vajra level is available to members by invitation only from our spiritual director. Each level supports the spiritual practice and understanding of members and is a reflection of their level of devotion to the lineage.
- 4.3 The criteria, privileges, and participation for all membership categories are outlined in the Membership Matrix in Appendix A to this Policy. The **Membership Structure** is outlined in the diagram in Appendix B to this Policy.

5. Program Participation

- 5.1 Responsibilities as outlined in the Membership Matrix are presented to guide and assist Society members with a better understanding of what level of involvement is most supportive of their spiritual growth. Programs include multi-week courses, weekly teachings and practices, and retreats. Participation tracking is self-managed by each Society Member. Society Members are asked to be mindful of their intended attendance and participation in Society activities when considering their membership level.
- 5.2 The ability to attend multi-week courses or weekly teachings and practices can be met by attending online. It is the Society's hope that members living outside of Edmonton will still take advantage of the opportunity to attend retreats and other events in person offered on weekends or during holiday periods.

6. Discounts

- 6.1 Discounts are offered for selected programming to allow the Society to recognize Society Members for their support. Society Members who are investing more time in the Society are offered a higher level of discount in recognition of the volunteer hours they are dedicating to the Society.
- 6.2 Website registration automatically calculates a discount when registering and paying for programming according to your level of membership.

7. Membership Fees

Membership fees are an investment in the Society. However, membership fees should not preclude individuals from applying. Any individual who feels they cannot afford the fee as stated is encouraged to contact office. The **President** or **Vice-President** in consultation with Kushok will consider the request.

Suggested Monthly Donations

As a registered non-profit society, the Society relies on Members' generosity to operate the Society's facilities, programs, and events. Offering a regular monthly donation is the best way to help the Society continue to exist for the benefit of others. Monthly donations, which are optional, are helpful as they stabilize the revenue flowing into the Society and make managing the facilities, programs, and events much more predictable. Monthly donations also allow memberships to practice generosity.

8. Application Process

Any individual interested in becoming a Society Member or renewing their membership is asked to do the following:

- a) Review the Membership Matrix to determine which membership category is the best fit. All new members are required to start at Lotus category.
- b) Print the current membership form from the Society's website and submit to the office in person or by mail or; complete the application on-line at https://www.gslab.ca/membership (preferred method).
- c) Fully complete the form and update or complete the Privacy Statement to consent to collection of your personal information.
- d) Submit the form along with payment to the Society Office or pay on-line.

9. Membership Term, New Member Admission, and Membership Renewal

- Memberships expire annually on December 31 of each calendar year, with the 9.1 exception of the **Honorary Life Member** which has no expiry date. Memberships cannot be transferred to another individual (non-transferable).
- 9.2 Individuals wishing to apply for a new membership are welcome to apply at any time of year. The fee if the individual applies after July 1 is 50% of the membership fee for the category. The membership is effective the date the payment is processed.
- 9.3 Existing Society Members who wish to renew their membership need to submit a completed application and payment online or to the Society Office before December 31. Membership renewal takes effect January 1 of the following calendar year.
- 9.4 Society Members who wish to change their membership category outside of the annual application or renewal process are asked to contact the President or Vice-President to discuss their request. The Society Member will be notified whether their request is accepted within 30 days. There will be no adjustment of fees when a Society Member chooses to change their membership to a different membership category outside of the annual application or renewal process.

10. Withdrawal

A Society Member may request in writing that their membership be withdrawn. There will be no reimbursement of fees when a Society Member chooses to withdraw their membership.

11. Member Conduct

All Society Members are expected to demonstrate behaviour that is in accordance with the Tibetan Buddhist teachings on ethics. For details see *Policy 12.2 Society Members' Code of Conduct and Discipline*.

12. Suspension and Expulsion

- 12.1 Society Members who fail to abide by *Policy 12.2 Society Members' Code of Conduct* may be subject to suspension or expulsion at the discretion of the Spiritual Director (see *Policy 3.2 Responsibilities of the Spiritual Director*). For details see *Policy 12.2 Society Members' Code of Conduct and Discipline*.
- 12.2 Once the Spiritual Director has made a decision to suspend or expel a Society Member, the Spiritual Director will notify the President verbally of the decision. The President will instruct the **Secretary** in writing to remove the individual from the **Register of Society Members**. The Secretary will notify the individual in writing of their suspension or expulsion, noting the date that the decision takes effect.

DEFINITIONS:

"Board" (as defined in the Bylaws), means the Board of Directors of the Society.

"Committee" means a committee established by the Board as provided in Bylaw 3.8 (which includes a standing committee such as an Operations Committee and a temporary committee such as an Event Based Planning Committee).

"Dharma" means the teachings of the Buddha.

"Event Based Planning Committee" means a temporary committee established by the Board to plan a particular event.

"Gaden Tripa Tradition of the Gelugpa Lineage of Tibetan Buddhism" means the lineage which follows the teachings of the philosopher Je Tsongkhapa. (The Gaden Tripa is the throne holder of Je Tsongkhapa on behalf of the Gelugpa lineage.)

"General Meeting" includes an Annual General Meeting and a Special General Meeting;

- "Honorary Life Member" means an individual belonging to the Honorary Life Member category of membership as provided in *Policy 1.2 Membership Eligibility, Privileges, and Responsibilities*.
- "Jewel Member" means a Society Member belonging to the Jewel category of membership as set out in *Policy 12.1 Membership Eligibility, Privileges, and Responsibilities*.
- "Lotus Member" means a Society Member belonging to the Lotus category of membership as set out in *Policy 12.1 Membership Eligibility, Privileges, and Responsibilities*.
- "Membership Matrix" means the matrix setting out the Society's categories of membership, as set out in Appendix A to *Policy 12.1 Membership Eligibility, Privileges, and Responsibilities*.
- "Membership Structure" means the diagram setting out the Society's membership structure, as set out in Appendix B to *Policy 12.1 Membership Eligibility, Privileges, and Responsibilities*.
- "Mission" means the mission of the Society as set out in *Policy 1.1 Vision and Mission*.
- "Objects" (as currently registered by the Province of Alberta's Registrar of Corporations) means the objects of the Society as follows:
 - a) To advance, disseminate, practice and celebrate the teachings, philosophy and study of Tibetan Buddhism and meditation, in particular that of His Holiness the Dalai Lama and the Ganden Tripa tradition of the Gelugpa lineage;
 - b) To provide religious and educational programs, retreats, meditations, knowledge and teachings in Tibetan Buddhist philosophy as noted in a) and Tibetan language, culture and religion;
 - c) To establish a meditation centre and such other facilities and to do such other necessary acts and things as may be consistent with the achievement and advancement of the aforementioned objects.
- "Operations Committee" means a standing committee that supports continuous operation of the facilities and programs of the Society.
- "Organizational Values" means the Society's values set out in *Policy 1.2 Organizational Values*.
- "Policy" means a specific policy approved by the Board as provided in Bylaw 3.2 and *Policy 2.1 Policy Development*.
- "President" means the individual occupying the office of President on the Board.
- "Register of Society Members" means the register of Society Members required to be kept by the Society further to section 36 of the *Societies Act* (Alberta).
- "Secretary" means the individual occupying the office of Secretary on the Board.

"Society" (as defined in the Bylaws) means Gaden Samten Ling Tibetan Buddhist Meditation Society.

"Society Member" means an individual whose name appears in the Register of Society Members (includes Lotus, Jewel, and Vajra members).

"Society Office" means the Society's office located in the Alberta Centre for Peace and Meditation, 11403-101 Street, Edmonton, Alberta, T5G 2A9.

"Spiritual Director" means the current Spiritual Director of the Society unless otherwise noted.

"Vajra Member" means a Society Member belonging to the Vajra category of membership as set out in *Policy 12.1 Membership Eligibility, Privileges, and Responsibilities*.

"Vice-President" means the individual occupying the office of Vice-President on the Board.

"Vision" means the vision of the Society as set out in *Policy 1.1 Vision and Mission*.

"Voting Member" (as defined in the Bylaws) means a Society Member entitled to vote at General Meetings as provided *Policy 12.1 Membership Eligibility, Privileges, and Responsibilities* (includes Jewel and Vajra Members,).
